Effective Date: The schedule attached is effective **July 12, 2015**.


Application of Increase: District No. 1 – National Marine Engineers Beneficial Association (MEBA).


The licensed engineer position pay schedule has been revised to include a 1 percent increase in basic rates. This increase is provided due to Division E, Title VII, Section 737(b), of the Consolidated and Further Continuing Appropriations Act of 2015 (P.L. 113-235, December 16, 2014). Under the provisions of 737(a)(4) of that law, the Office of Personnel Management (OPM) also approved a 1 percent increase in premium pay rates (e.g., overtime, penalty pay, scuba diving, tank cleaning, dirty work, non-watch standing allowance, and monthly leave supplement).

Crews-of-vessels are appointed to the unclassified service under 5 C.F.R. § 213.3114(j)(3) with pay rates established under the statutory authority contained within 5 U.S.C. § 5348.

Effect on Other Schedules: The schedule for licensed engineer positions (Boston Pay Area) effective July 13, 2014 is superseded.

Dear Ms. Carpino:

Thank you for your letter requesting approval to grant increases in Fiscal Year (FY)-2015 premium pay elements for marine wage employees of the National Oceanic and Atmospheric Administration. We approve your request and authorize you to adjust pay elements for those employees up to the maximum permissible FY 2015 amount of 1.00 percent, provided no rate exceeds the industry prevailing rate. In addition, no such increase may be less than the minimum prevailing rate adjustments shown in the table below.
